## Criteria for electrical trade test application

The Trade test criteria is as follows:

- 3 years relevant on-the-job experience with N2 or higher (with 4 subjects relevant to a trade) **OR**
- 3 years relevant working experience with relevant engineering NCV qualification at NQF Level 3 **OR**
- 18 Months relevant working experience plus completion of relevant working experience modules and relevant engineering NC(V) 4 **OR**
- 18 Months relevant working experience (directly related to the trade theory subjects) N6 Technical certificate or National Technical Diploma ( S or N stream) **OR**
- 3 years relevant working experience with technical Grade 12 with Maths, Engineering Science and related trade theory subjects **OR**
- 4 years relevant working experience with Grade 9 with Maths passed **OR**
- 80 weeks relevant on-the-job experience with Engineering Learnership, NQF levels 2,3 &4 related to the trades listed above

When the trade test application has been approved you will be required to do the following before you can do the Trade test:

- Trade test evaluation
- Gap training (if the evaluation shows that you have any)
- Trade test preparation
